



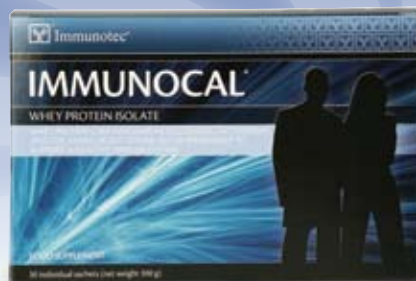

Trinidad & Tobago operates as a seamless market.

You can now build an international downline organization as easily as expanding your existing organization. All consultants join using a US application and Agreement form.

All TT consultants join by completing a US Application and Agreement form, and they must purchase a US Consultant Kit. For existing Consultants, simply include your identification number on new recruits Application and Agreement form or have your new Consultants register on line. All new Consultants will be assigned an identification number and you will see their orders and activities in your downline report. Commissions will be remitted in US dollars



GET STARTED NOW!

When you sponsor a new Consultant they will purchase and receive a basic US Consultant Kit, which contains educational, training and marketing materials on the products and the business opportunity. Although not all US products are available in TT we do include everything they need, in an easy-to-follow and step-by-step system so as to get them started quickly and easily.

REGISTERING YOUR NEW IMMUNOTEC CONSULTANT:

All Applications and Agreement forms must be submitted either by fax or online or registration can be done by phone. The toll free fax number for Trinidad & Tobago is 1 800 204 0002. The toll free Customer Service/Support line is 1 800 204 0003. All new Consultants and customers will register and purchase using a Visa or MasterCard credit card only. Transactions are in US dollars. No checks or other methods of payment will be accepted.

PURCHASING PRODUCTS:

Your Consultants will purchase directly from the ImmunoTec Customer Service/Consultant Support department or online. Consultants will be prompted to select one of three pick up locations in Trinidad & Tobago.

PICKING UP YOUR ORDERS:

Shipping & Handling are added to the price of the product. Orders that are placed before 12:00pm can be picked up after 2:00pm the same day. All orders placed after 12:00pm are available for pick up the next business day. Opening hours for all Pick up centers are Monday to Friday 8:00 a.m. to 4:00 p.m It is best to call the key contact person before picking up your order at least one hour before collecting your orders to ensure that the invoice has been received and all is prepared in advance for a hassle free pick up.

Commissions will be paid to Consultants in Trinidad & Tobago by checks. Commission checks will be posted in Trinidad & Tobago on the 15th day of every month. Consultants should allow 3-5 business days to receive their check.
